This organization consists of the 20 California counties formed under the County Employees Retirement Law of 1937. The conference was held in Emeryville and hosted by the Retired Employees of Alameda County. The keynote speaker was Rosa 'Rosie' Gumataotao Rios, the 43rd Treasurer of the United States. In April 2016, the Treasury announced that women will be placed on the \$5, \$10 and \$20 bills reflecting the theme of democracy. The concepts will be unveiled on August 26, 2020 in recognition of the 100th anniversary of the 19th amendment granting women the right to vote. That a way, Rosie!!!

Other topics covered were retiree wellness, Affordable Care Act update, emergency services update, retiree benefits litigation and a presentation on the 'Millennials'; yes, after the baby boomers came GenX and now in the workplace we have the Millennials. We continue to have new retirees joining SCREA each month, but sadly we also have the deaths of members that offset the rate of growth in membership. I have enjoyed my experience and learned much in my short 3 years on the Board and, if not for making the move out of the area, I would gladly continue to serve on the Board of Directors.

All the providers were present to answer any questions about their plans. There was a lot of information available that I was totally unaware of; for instance, were you aware that VSP offers discounts on hearing aids? It can be very beneficial to attend these as sessions as benefits within the different plans can vary.

Remember, as well as the county benefits, SCREA members also have access to supplemental benefits provided by the Pacific Group Agency (PGA). ## **ELDER SCAMS (Section Three)**

This is the third installment of the article dealing with Elder Scams and some scams in general. It is estimated that more than \$36 billion dollars per year is lost due to scams. The majority of the losses are from the elderly. **Be vigilant!**

### **Pets-for-sale Scam**

A pet-for-sale scam involves scammers creating a fake website that offers pet adoptions or providing individuals an opportunity to make a donation to a fictitious animal nursery. The website showcases a wide variety of animals that can be adopted at significantly lower than market price. Victims are required to only pay for the insurance and other fees associated with shipping their new pet to their home. The only form of payment accepted is a Moneygram, Western Union or a non-returning money transfer to an overseas bank account. Everyone should avoid paying for a pet by transferring money into another person's bank account.

### **Collection Agency Scam**

Scam artists are well aware that collection agencies have the right to contact individuals who are behind in their monthly bills. They identify themselves as a representative of a fictitious collection agency that is threatening a lawsuit unless the victim settles their current debt issue. Some scam artists support their claims with actual information about the person's bad credit history. This type of scam can go on for a long period of time, as the phone call harassment will continue until the victim breaks down and makes a payment over the phone. A few months later, the same vicious cycle begins once again to acquire more money from a helpless victim.

### **Working from Home Scam**

Every person's dream is working from home on an everyday basis. After all, it's a convenient way to avoid the stresses of commuting back-and-forth from our homes to the workplace. This scam centers around setting up a fictitious website that offers work-at-home positions within the international shipping department. The victim goes through the interview process on instant messenger or email correspondence. Once hired, the company begins to send packages to the new employee's home with explicit instructions on how to inspect the product before shipping it elsewhere. Soon after, communication between the company and employee ceases, as they receive a fictitious paycheck that is greater than time worked. Finally, the employee is able to get in contact with their employer about the overpayment in their paycheck. The company confirms the mistake and tells the employee to send the difference back before depositing the check. Unfortunately, the victim will receive notice that the paycheck has bounced with no recourse to recover the money from their vanished employer.

### Peppermint Bark

#### Ingredients

- 12 oz quality white chocolate
- 12 oz quality dark chocolate
- 1/2 cup crushed peppermint candy (Starlite or others)

#### Instructions

1. Line a 9" x 12" pan with parchment paper.
2. Melt the dark chocolate in double broiler or in a microwave for 30 seconds, stir & repeat until it has a smooth consistency. Pour melted chocolate on parchment paper & spread to about 1/3" thick.
3. Melt the white chocolate in the same way as the dark chocolate. After white chocolate is smooth, pour it on top of the dark chocolate. Try to make this layer the same thickness as the dark layer. (It's better to spread the white chocolate when it is still very soft as they seem to stick together better if the white layer has not hardened).
4. Unwrap peppermints & put into heavy duty ziplock bag. Using hammer or meat tenderizer, crush mints. Sprinkle on top of white chocolate while it is still melted/soft.
5. Let chocolates harden in the refrigerator for 2 hours. Break into pieces. Store in air-tight container.

## SACRAMENTO COUNTY EMPLOYEES' RETIREMENT SYSTEM (SCERS) APPOINTS NEW CEO

Following a lengthy and comprehensive nationwide recruitment process, the SCERS Board reached agreement with Eric Stern to serve as Chief Executive Officer of SCERS. Appointed by the SCERS Board, Mr. Stern is expected to assume the duties in early December 2017. Mr. Stern fills the position vacated by long-serving Richard Stensrud who retired this past May 2017.

As Chief Executive Officer, Mr. Stern will serve at the will and pleasure of the SCERS Board. He will be responsible for the overall management and administration of the System in accordance with the direction, policies and goals set by the SCERS Board and in compliance with applicable state and federal laws.

Mr. Stern, comes from the California State Department of Finance and leads the program on retirement and health benefits. For the last decade Mr. Stern has been at the center of the changes to sustain California's public employee retirement systems. He has worked at all levels of government, bringing together labor and management to forge solutions.

"Eric Stern has the vision and drive to lead the implementation of our long-term strategic plan, continue developing our dynamic team of investment and benefit staff, and align our operating authority with our fiduciary responsibilities," said SCERS President Rick Fowler. "With the growing complexity of both pension regulations and global financial markets, we need not only his pension expertise but his ability to work with key stakeholders including the members of SCERS, appointed officials and all


