### **PRESIDENT'S MESSAGE** By Randal Angeloni, President

Hello SCREA Members....We have all heard the stories about cyber-crimes perpetuated on others. We hoped it would not affect us. The reality is that it can. PERS was attacked thru a third-party contractor. From a KCRA news item dated June 24, 2023...

"The personal information of about 769,000 retired CaIPERS members was exposed in a third-party data breach that was reported earlier this month. CaIPERS said Wednesday that its third-party vendor PBI Research Services/Berwyn Group notified the agency on June 6 of a vulnerability with its MOVEit Transfer Application that has since been fixed."

If you or yours has been involved in this breach, contact PERS to find out what you need to do about it. I am hoping by now you would know if you are a PERS retiree.

A note on the SCERS website reads:

"The cyberattack which occurred in late May and affected numerous major organizations around the world, exploited a vulnerability in software used by PBI Research Services/ Berwyn Group, known as PBI. Death-audit service providers like PBI monitor retiree lists for unreported deaths to ensure benefits are not overpaid.

Although SCERS uses death-audit services through Berwyn, which merged with PBI this year. SCERS member data has not been compromised by this cyberattack."

If you attended the June SCREA luncheon you know that four members were elected to the Board of Directors. (Please see the Nominating Committee Report on page 6). Also on the ballot during the luncheon was an increase in SCREA membership dues. We have never had dues increase since the inception of this organization in 1975. The vote was unanimous of those present at the luncheon to increase the dues for members from \$1.00 per month to \$2.00 per month and the associate members from \$.50 to \$1.00 per month.

The directions to Mather Lake Regional Park, Rotary Grove are as follows:

#### From Folsom, CA (Hwy 50)

Take Hwy 50 and exit at Sunrise Blvd. Turn left at top of ramp. Continue on Sunrise Blvd for approx. 4 miles then turn right on Douglas Rd. Continue on Douglas Rd for approx. 1 mile and turn left onto Zinfandel Dr. Look for the entrance and signs on the left.


