MissionSquare – Retiree Health Savings Plan:

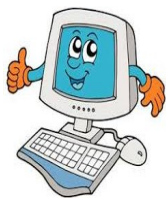
We're partnering with MissionSquare to provide a 30-minute informational session on the Retiree Health Savings Account including how to file claims.

REMEMBER

DUES INCREASE VOTE

This is a reminder that at the June luncheon, the general membership (**member retirees in attendance**) will be voting on the SCREA Board's proposal for an increase in the monthly dues which we all pay, including the Board members and officers.

As you know, inflation is everywhere. Our dues have not increased since the SCREA was founded in the 1970's. We have strived to keep dues both reasonable and constant even though our expenses have significantly increased also. Our largest expenses include costs associated with the luncheons, printing and mailing the quarterly newsletters, and rental of a storage locker for our official documents. Since the fiscal year 2013-2014, even after taking into account a 16% increase in membership, our expenses have increased by nearly 33%. We are anticipating another increase in annual costs next year as well.

As a result, the Board is requesting an increase in dues to \$2 per month (\$24/year) from our members. Dues for Associate Memberships (Spouse, Domestic Partner, and Surviving Spouse) would increase to \$1 per month. This proposal will be voted on, in accordance with the bylaws at the annual meeting, June 16, 2023 at the Dante Club. **PLEASE COME AND VOTE!!**

VOLUNTEERS NEEDED!

The California State Railroad Museum (SSRR) is again looking for volunteers that enjoy inspiring visitors of all ages and explaining to them the history and importance of the railroad and how it affected the growth of California. Many special train excursions are scheduled throughout the year including the Halloween Train and the Polar Express where docents may work. Polar Express volunteer training usually occurs during the month of October. You are not required to be a docent to volunteer for Polar Express.

Due to unfortunate circumstances, excursion trains will not run for a 4 month period this year starting in April. However, volunteer and docent training will still be held to prepare for the fall trains.

Volunteer and docent training typically takes place two times a year: spring and fall. There are two paths volunteers may follow: work in the Railroad Museum and/or with the Sacramento Southern Railroad (SSRR).

Docent/Volunteer Training

Upon entry to the volunteer program, volunteers may choose training for the Railroad Museum or SSRR. The first few sessions are attended by all volunteers together. After learning how to interpret, docent trainees will then decide which path to take. Museum docents will follow a specific training schedule; however, those who want to be involved with SSRR operations, including signals, working on the trains, etc. will complete a different training.

Should you decide to volunteer at the museum, there are a wide variety of opportunities such as: Library & Archives, School Programs, Maintenance of Way, Signals Maintainer, Upholstery Shop, Huntington Hopkins Hardware Store, Research, Tour Guide and more.

Volunteers are asked to work at least 84 hours per year, which equals seven hours per month. You will choose the program(s) in which you wish to work and what days and times you volunteer. There is no fee to become a volunteer and parking in the Museum's parking lot is made available to volunteers who work the required 84 hours per calendar year.

An Often Overlooked Gift: The Opportunity to Prepare

Unexpected things happen that leave us no opportunity to prepare. One of the hardest things to process in life is the unexpected loss of a loved one. Grief hits everyone differently, but one thing everyone has in common while navigating the brutal waves of grief is the desire to honor their loved ones the way they see fit.

The intent to honor a loved one frequently gets clouded by confusion and complication of estate planning. Establishing a living trust in advance provides the ease of distribution of the estate in a seamless, predetermined manner, allowing your loved ones to focus on processing their grief.

Without a living trust, your estate is subject to probate. Probate is a legal process overseen by the courts that takes place when someone passes away without a living trust. Currently in the State of California, probate takes a minimum of one to one and a half years. There are also significant fees involved, which vary depending on whether or not a Court Administrator is assigned to your case. For a million dollar estate, those fees range from \$25,000 to \$50,000. Those fees come directly out of the estate, rather than going to your family or loved ones.

Another drawback of probate is that it is a public proceeding. Aside from the lack of privacy, this also creates the opportunity for fraudsters and creditors to become aware of and possibly try to take advantage of the situation. This can create more chaos and heartache during an already difficult time.

In addition to predetermining financial matters, a living trust also often comes with powers of attorney, one for medical issues and one for financial issues. If you become incapacitated and cannot speak or act for yourself, this allows you to preselect someone to do so on your behalf. A living trust also allows for the nomination of guardians, allowing you peace of mind to know your children will be cared for by someone of your choosing.

Think of estate planning as creating a key. You can create this key by establishing a living trust and hand the key to whomever you choose or you can let the courts make a key and hand it to whom they deem most appropriate, and on their time, at their cost. You have the gift of an opportunity to remain on duty for those you love after you are gone. I hope you will consider honoring yourself and your loved ones by taking advantage of this gift and creating a living trust.
