## **UPDATE FROM THE EMPLOYEE BENEFITS OFFICE**

#### Annual Review

As we head towards the end of the year, it is a good time to take stock of all the blessings in our life, including our family and friends and all the things we have done together throughout the year. It is also a good time to review our health and finances and look forward to planning for the new year.

From the County, you may have several resources for your use in retirement.

#### Retiree Health Savings Plan (RHSP)

Back in 2007, the County began to put \$25 per pay period into a Retiree Health Savings Plan (RHSP) towards your retiree health expenses. Some bargaining units decided not to have or continue with this benefit (002, 004, 008, 022, 023, and 025), so you may not have an account or may have a smaller account. All other bargaining units have RHSPs. This account offers tax-free reimbursement of health expenses, like medical, dental, vision, prescriptions, premiums, and Medicare Part B expenses for you, your spouse, and/or some dependents. The current RHSP carrier is MissionSquare and the claim administrator is Meritain. Due to the rules for a RHSP, it is better to exhaust this account prior to using other Medical Savings Accounts. Please take advantage of the RHSP to cover your healthcare expenses.

#### **Health Savings Accounts (HSA)**

If you had a High Deductible Health Plan (HDHP), then you may have also contributed to a Health Savings Account (HSA). HSA funds can be used for qualified medical, dental, vision, and hearing expenses. Once you are age 65+ they can also be used for medical premiums. If you are under age 65 and using HSA funds for non-medical reasons, there is also a 20% tax penalty. If over 65 years or older, there are no penalties. No matter your age, if using these funds for non-medical reasons, they are taxed as income. Using HSA funds for medical purposes is tax-free. If you had Kaiser or Sutter health insurance while employed, you could have had an HSA with Optum Bank. If you had Western Health Advantage health insurance, then you could have had an HSA with Health Equity.

#### **Deferred Compensation**

As a retiree who has a deferred compensation account (457(b) and/or 401(a), you can continue to work with the County's provider Fidelity and meet with our contracted Financial Advisor as part of that benefit. See the article in this newsletter from Fidelity (page 5).

#### Other Benefits

The County offers medical, dental, and vision insurance to retirees. Pre-65 retirees can use Kaiser, Sutter, or Western Health Advantage for their medical insurance. At age 65+, then Medicare Advantage plans are available in the area through Kaiser and United Healthcare. Those living out of area can purchase medical insurance through Kaiser in some states and through WHA Anthem

# Sacramento Chinese Community Service Center, Inc. and AARP Foundation Experience Corps Seek Volunteers to Help Students in Grades K-3 Become Better Readers

(**Sacramento, CA**) — Sacramento Chinese Community Service Center (The Center) is seeking 35 volunteers for <u>AARP Foundation Experience Corps</u>, an intergenerational, community-based program that engages volunteers ages 50 and older as tutors and mentors to help students in grades K-3 become proficient readers by the end of third grade.

For the last seven years Experience Corps Sacramento has been working to address this . problem. The program model is a proven intervention with measurable benefits for both students and volunteers. 40% of last year's student participants reached the grade level benchmark in reading by the end of year. Children are able to improve their literacy and social-emotional learning skills, while volunteers report positive mental and physical benefits from actively serving their communities.

Experience Corps volunteers provide an average of 4 hours of support each week at one of 10 local schools within the Sacramento City Unified School District. Tutoring takes place inperson during after school hours. Students who participate work with their tutor twice a week for 30 minute sessions. To qualify, volunteers must be at least 50 years of age and must undergo a screening process. No teaching experience is necessary as all Experience Corps volunteers receive in-depth training, access to on-going educational workshops and networking opportunities with fellow volunteers.

Tutoring begins in November 2023 with ongoing enrollment through January 2024. # CRANBERRY-CHERRY PIE—A great pie for any holiday

#### Filling

1—10 oz. can cherry filing
1—14 oz. can whole cranberry sauce
1/4 cup sugar
3 Tbsp. quick cooking Tapioca
1 teas. lemon juice
1/4 teas. cinnamon
2 Tbsp. butter or margarine
Milk

Pastry
2 cups sifted cake pastry flour
3/4 teas. Salt
1 cup shortening
4 Tbsp. water

Combine all filling ingredients except butter & milk. Let stand 15 minutes.

For pastry, combine four & salt; then cut in shortening until mixture is uniform (should be fairly course). Sprinkle with water, 1 tablespoon at a time; toss lightly with fork. Work into a firm ball; roll out half for the bottom crust & half for lattice strips.

Preheat oven to 400 degrees. Line 9" pie plate with half pastry; add filling. Dot with butter. Place lattice crust over filling; seal & flute edges. Brush lattice top with milk. Bake 40 to 50 minutes or until crust is golden brown. (Cover edge of crust with foil after 15 minutes to prevent overbrowning.) Makes 1 pie. Enjoy!!
